




Article 8: Upon dissolution the assets shall be distributed:

Article 2: The purpose for which the corporation is organized is:

Purpose:

The corporation is organized exclusively for charitable, benevolent, educational, and religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code (or corresponding provision of any future U.S. IRS Code) in order to provide life changing transformation through the healing power of the Spirit of God.

The corporation will solicit, receive, and maintain funds to use in furtherance of the above purpose in accordance with its mission and vision set out below.

Among other things, this includes the fact that no part of the funds received or earnings of this corporation shall inure to the benefit of any private member or individual except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of its purpose, mission, & vision.

In addition, no substantial part of its activities will be to carry on propaganda, or otherwise attempt to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
