The undersigned, acting as incorporator of a corporation under the Idaho Professional Service Corporations Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the Corporation is ST. MARIES CHIROPRACTIC, P.A.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the Corporation is organized is to provide chiropractic services to the general public together with all related activities and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Professional Service Corporations Act.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 100,000 shares, with a par value of \$ 10.00 per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: The internal affairs of the Corporation shall be governed by a duly adopted code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.

SEVENTH: The address of the initial registered office of the Corporation is 1117 Main Avenue, Suite #4, St. Maries, Idaho 83861, County of Benewah, State of Idaho, and the name of the registered agent at such address is Marlene K. Saunders Hess.

EIGHTH: The number of directors constituting the initial Board of Directors of the Corporation is one (1), and the name and address of the person who is to serve as director until the first annual meeting of shareholders, or until their successors are elected and shall qualify, is:


