ARTICLES OF INCORPORATION  
OF  
FORREST JOHNSON'S ELECTRIC & REPAIR, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all natural persons of full age, citizens of the United States and residents of the State of Idaho, have this day associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

1. NAME: The name of the Corporation is FORREST JOHNSON'S ELECTRIC & REPAIR, INC.
2. PURPOSES: The nature of the business of purposes to be conducted or promoted are: The business of electrical contracting and repair, pump installation and maintenance, repair of small machinery, and manufacture, design, construct, own, buy, sell, lease, hire and deal in and with articles and property of all kinds and to render services of all kinds; and to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Idaho.
3. DURATION: The Corporation shall have perpetual existence.
4. LOCATION AND POST OFFICE ADDRESS: The location of the registered office of the Corporation shall be at Hazelton, Jerome County, Idaho. Its post office address is P.O. Box 218, Hazelton, Idaho 83335. The registered agent at such address is Forrest Glen Johnson.
5. AUTHORIZED SHARES: The aggregate number of shares which the Corporation shall have authority to issue is 10,000 shares with a par value of \$1.00 each, all of one class, which shall be designated common stock.
6. PAID IN CAPITAL: The amount of paid in capital

with which the Corporation will begin business is Five Hundred and no/100 Dollars (\$500.00), and the Corporation will not commence business until consideration of that value has been received for issuance of its shares.

8. DIRECTORS: The management of the affairs of this Corporation shall be vested in a Board of three directors, and the terms of office, qualifications of directors and manner of election or appointment shall be provided for in the By-Laws. CUMULATIVE VOTING: At any election for Directors, a shareholder shall have the right to cumulate his votes by giving one candidate as many votes as the number of directors to be elected, and for whose election he has a right to vote, multiplied by the number of his shares, and any shareholder shall have the right to cumulate his votes by distributing such votes on the same principal among any number of such candidates.

10. PEREMPTIVE RIGHTS: Shareholders of this Corporation shall not have peremptive rights to acquire additional shares issued by the Corporation.

11. AMENDMENTS: The Corporation reserves the right to amend, alter, change or repeal any provision of these Articles, in the manner now or hereafter prescribed by law, and all rights and powers conferred herein on shareholders and directors are subject to this reserved power.




