

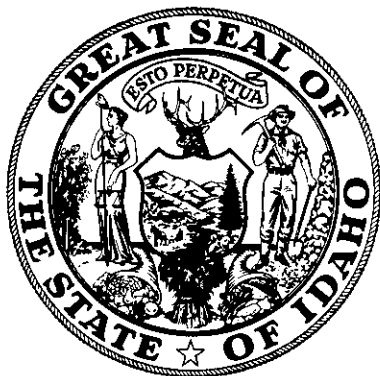
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
SNAKE RIVER ASSOCIATES, INC.

NOW, THEREFORE, IT IS MUTUALLY AGREED, AS FOLLOWS:

Formation of Corporation:

1. The parties hereto shall forthwith form and organize a corporation under and pursuant to the laws of the State of Idaho, by the name of Snake River Associates, Inc.

Purpose of Corporation:

2. To carry on all or any business of an analytical testing laboratory and an environmental consulting firm, and to do all other things necessary and relating thereto;

To carry on all or any of the business of an independent manufacturers representative for consumer products, and to do all other things necessary and relating thereto;

To purchase, acquire, hold and dispose of the stocks, bonds, and other evidences of indebtedness of any corporation, domestic or foreign, and to issue in exchange therefore its stocks, bonds, or other obligations, and to exercise in respect thereof all the rights, powers and privileges of individual owners, including the right to vote thereon;

To aid in any manner permitted by law any corporation of which any bonds or other securities or evidences of indebtedness or stocks are held by this corporation, and to do any acts or things designed to protect, preserve, improve or enhance the value of any such bonds or other securities or evidence of indebtedness or stock.

Office of the Corporation

3. The office of the corporation is located in the City of Boise, County of Ada, State of Idaho.

Stock Issuance

4. The aggregate number of shares which the corporation shall have the authority to issue is:
