ARTICLES OF INCORPORATION OF CERVED AUTO PARTNER, INC. SEC. OF STATE

The undersigned, acting as incorporation Act, adopts the following Articles of Incorporation for such corporation.

- 1. NAME: The name of the corporation is AUTO PARTNER, INC.
 - 2. DURATION: The period of its duration is perpetual.
