That we, the undersigned, all of whom are residents of the State of Idaho, have this day voluntarily associated cursolves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

Ï

That the mame of said corporation shall be MEADOW CREEK INVESTIGHT CUMPANY.

II

That the purposes for which it is formed are:

At To buy and otherwise acquire, or, to lease or take options for leases, or to purchase, to hold and sem, manage, sperate, improve, develop, and sell lands, mining claims, mineral rights including rights to all and gas, all wells, and other real estate and interests and rights in and to any of said property, either in severalty or as a joint tenant or tenants in common with others, or otherwise.

B: To engage in end carry on the business of drilling and exploring for oil, producing, refining, distilling, treating, manufacturing, piping, darrying, bandling, storing, dealing in, buying and selling oils, petroleum, natural gas, asphaltum, bitumen, bituminous rock, and other mineral and hydro-carbon substances, and products of all other substances; and for such purpose to buy and otherwise sequire, hold, sun, manage, and operate refineries, pipe lines, tanks, manufactories, machinery, tank-cars and other wrks, property and appliances that may be incident ar auxiliary to said business, or that may be deemed assessary or convenient to the board of directors;

G: Also to take and acquire by purchase, emchange, ar other latful modes, and to hold, our, sell and otherwise dispose of the expital stock and books of other corporations;

B: Also to establish agencies, effices, storage tanks and houses, and to sell articles and products samufactured by itself, or other persons or corporations, in Ideho, and other states or territories of the United States of America, and in foreign countries.
