ARTICLES OF INCORPORATION

OF

INTERMOUNTAIN SKYLINES, INC.

The undersigned incorporators, desiring to form a Corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE

Name: The name of the Corporation is Intermountain Skylines, Inc.

ARTICLE TWO

Purposes: The purpose of the Corporation is to engage in the general logging business, together with the building of logging roads and other things necessary in the full and complete operation of the logging business; to purchase, or otherwise acquire, sell or dispose of logs or other wood products in a processed or unprocessed state; to engage in the business of hauling and transporting logs, timber and equipment, by means of trucks and other forms of transportation, over public or private highways, or roads; and to conduct such other business as is usual, proper and necessary in such business enterprise. The Corporation may further engage in any or all lawful business for which

Corporations may be organized under the Idaho Business Corporation Act.

ARTICLE THREE

Duration: The period of duration of this Corporation is perpetual.

ARTICLE FOUR

Registered Office and Registered Agent: The address of the Corporation's initial registered office in the State of Idaho is 310 1/2 South Main, City of Moscow, County of Latah, State of Idaho 83843. The name of the Corporation's initial registered agent at such address is John C. Thomas.

ARTICLE FIVE

Stock: The total authorized number of par value shares of stock is Thirty Thousand (30,000). The aggregate par value of the total authorized number of par value shares is Ten Dollars (\$10.00) per share.

ARTICLE SIX

Transfer of Stock: In case a stockholder desires to sell his or her shares of stock, the stockholder must first offer them for sale to the remaining stockholders, it being the intention to give them a preference in this purchase of such shares, and any attempted sale in violation of this provision is null and void.

A stockholder desiring to sell his or her stock shall file notice in writing of the stockholder's intention with the secretary of the Corporation, stating the terms of sale, and unless the stockholder's terms are accepted by any or all other stockholders within thirty (30) days thereafter, they shall be deemed to have waived their privilege of purchasing and the stockholder will be at liberty to sell to anyone else.

ARTICLE SEVEN
