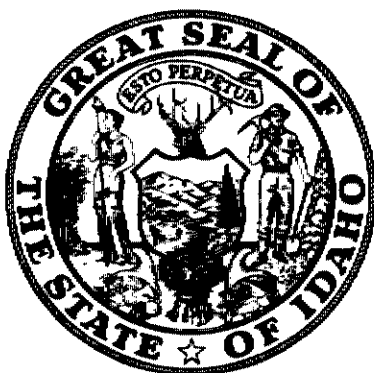

for

- (1) The name of this Corporation shall be ROSENVOLD PUBLICATIONS, INC.
- (2) This corporation is intended to be and will remain a non-profit corporation.
- (3) It is intended that this corporation shall be perpetual.
- (4) The purpose of Rosenvold Publications, Inc. is the publishing and dissemination of religious books and literature, and books and literature on health matters.
- (5) The initial membership consists of three (3) members. All members shall sit on the board of directors of the corporation. Rosenvold Publication, Inc., P. O. Box 330, Hope, Idaho 83836, will have the authority to elect additional members and directors.
- (6) This corporation will abide by the Laws of the State of Idaho and will be able to conduct such acts or practices as are permitted by law and not inconsistent with such laws. Specifically, Title 30, Chapter 3, Idaho Code, Idaho Non-profit Corporation Act as set forth on pages 70 to 80 of such Title and Code.
