I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of

FIRST BAPTIST CHURCH OF RUPERT, IDAHO, INC.

was filed in the office of the Secretary of State on the **Fifteenth** day of May.

A. D. One Thousand Nine Hundred Sixty-two and is duly recorded on Film No.

119 of Record of Domestic Corporations of the State of Idaho,

and that the said articles contain the statement of facts required by Sections 30-103, 30-1101 and 30-1102, Idaho Code.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence—from the date hereof, with its registered office in this State located at Rupert—in the County of Minidoka and as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

OF

FIRST BAPTIST CHURCH OF RUPERT, IDAHO, INC.

KNOW ALL MEN BY THESE PRESENTS: That we the undersigned, all of whom are natural persons of lawful age, and citizens of the United States and residents of the State of Idaho, and associated together as members of the First Baptist Church of Rupert, Idaho, a religious organization of which pecuniary profit is not an object, in accordance with the rules, regulations, laws and discipline of such organizations, and for the purpose of forming a religious corporation under the laws of the state of Idaho, do now, on this lst day of May, 1962, hereby voluntarily associate ourselves together, and do hereby make and execute the following Articles of Incorporation, and do hereby certify as follows, to-wit:

ARTICLE I

The name of this corporation shall be First Baptist Church of Rupert, Idaho, Inc.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The location and post office address of the registered office of this corporation, and the place where the principal business of this corporation is to be transacted is 807 5th. Street, Rupert, Idaho.

ARTICLE IV

The purpose for which the corporation is formed and is to be conducted is to give corporate existance to the members of the Church, a religious organization known as the First Baptist Church of Rupert, Idaho, Inc., for the sole purpose of operating a Church; to purchase, hold, lease, rent, sell or mortgage real property for the purposes of owning and operating, conducting and carrying on said religious organization and to do all things necessary; to purchase, take, hold, lease, rent, sell or mortgage personal property for the purpose of owning or operating a religious organization, and to do all things incidental, necessary or convenient in the carrying out of the foregoing purposes.

The above enumerated purposes shall also be considered as a statement of powers, and this corporation may do each and every thing suitable or proper for the accomplishment or attainment

of any one or more thereof, or conductive to, or expedient for the interest or benefit of the corporation. In addition thereto, the corporation shall have, and may exercise any other or further rights, powers and privileges granted by law to corporations of a religious character.

ARTICLE V

Pecuniary profit is not the object of this corporation and it shall have no capital stock. The government of this corporation and the management of its affairs shall be vested in a board of five trustees, all of whom shall be duly elected, qualified and acting officers of the First Baptist Church of Rupert, Idaho, Inc.

The Board of Trustees shall be elected from their own number and shall serve for such period of time that may be provided in the By-Laws of the corporation.

ARTICLE VI

All real and personal property heretofore owned by the First Baptist Church of Rupert, Idaho, shall be and become the property of this corporation, and title to all of said property shall pass immediately to and become vested in this corporation.

ARTICLE VII

That a duly called meeting of the members of the First Baptist Church of Rupert, Idaho, Inc., was held in the Church building in Rupert, Minidoka County, State of Idaho, which said Church building is the meeting place where the members and congregation of said Church regularly meet, and which said meeting was held on the 29th day of April, 1962, at the hour of 8:00 o'clock P.M. of said day, at which meeting a majority of the members who were present voted for the election of trustees; that due and regular notice of the time and place of holding such meeting and election was given by publication thereof for more than two weeks, on the following dates, to-wit: April 19 and April 26, 1962, in the Minidoka County News, a newspaper published and of general circulation in Rupert, Minidoka County, Idaho, the city where said election was held, and was published in every issue above named, and by posting a like notice in a conspicuous place on the front door of the building where such election was held, for more than two weeks prior to said meeting, and said notice having been posted at all times from posting date of April 16, 1962, until the time of said election; that notice was also given each and every member of the First Baptist Church of Rupert, Idaho, of said meeting and election and that the question of incorporation of said Church was to be considered at said meeting, and at said meeting the following persons were duly elected and qualified as Trustees and the officers of the said First Baptist Church of Rupert, Idaho, Inc., to-wit: Nolan B. Humphreys, Paul, Idaho, and Guy Rumsey, Floyd W. Brady, Jake Wall, J. W. Frazier and James Rudolph of Rupert, Idaho.

ARTICLE VIII

That the names of all of the incorporators of this corporation are listed for trustees in article VII hereof, and that the post office address of each of said incorporators is as follows:

ARTICLE IX

That at said meeting these Articles of Incorporation were by unanimous vote duly adopted, and said persons so elected as trustees were duly authorized and directed to execute and file the same for record, and to duly incorporate the First Baptist Church of Rupert, Idaho, for and on behalf of its members.
