RE-STATED ARTICLES OF INCORPORATION
OF
NORTH IDAHO RV & TRUCK, INC.
(FORMERLY NORTH IDAHO'S USED RV & TRUCK CENTER, INC.)

The undersigned, DON HELMS, Chairman of the Board of Directors of the corporation organized September 20, 2000 under the Idaho Business Corporate Act, upon the unanimous approval of the Board of Directors and the Shareholders, makes these Re-States Articles for the sole purpose of a name change of the corporation under the laws of the State of Idaho, and does hereby make, adopt, execute, and acknowledge these Re-States Articles of Incorporation, effective upon filing, as follows:

ARTICLE I: Corporate Name

The name of the corporation shall be NORTH IDAHO RV & TRUCK, INC.

ARTICLE II: Shares

The corporation shall have authority to issue 500,000 shares of common voting stock.

ARTICLE III: Initial Registered Office and Registered Agent

The initial registered office of the corporation shall be located at 675 Schweitzer Mountain Road, Sandpoint, Idaho 83864. The initial registered agent at the address shall be DON S. HELMS.

ARTICLE IV: Initial Board of Directors

The number of directors of this corporation shall be not less

The purpose for which this corporation is organized is the transaction of any and all lawful business.


ARTICLE VII: Cumulative Voting
