

ARTICLES OF INCORPORATION  
of the  
IDAHO NORTHERN RAILROAD COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, that we, W. Thomas Hart of Weiser, Washington County, Idaho, Joseph Perrault of Boise City, County of Ada, Idaho, Alfred Eoff of Boise City, Ada County, Idaho, Bamford A. Robb of Boise City, Ada County, Idaho, and Bamford Robb of Portland, Oregon, do hereby associate ourselves as a corporation under the general incorporation laws of the State of Idaho, and do hereby adopt the following articles of incorporation:

ARTICLE I.

The name of the corporation shall be the Idaho Northern Railroad Company, Limited.

ARTICLE II.

The purposes for which the corporation is formed shall be,

First. To build, construct, or acquire and equip the following railroad and telegraph lines, to-wit:

1. A line of Standard Gauge railroad and a telegraph line commencing at a point at or near the mouth of the Coeur d'Alene River in the State of Idaho, and thence along said river on either bank thereof, to the north fork of said river; thence along said north fork, on either bank thereof, to Prichard Creek; thence along said Prichard Creek, on either bank thereof, via Murray in the State of Idaho, to the head waters of Bear Gulch in said state, and the boundary between Idaho and Montana; the estimated length of said line being seventy-five miles.

2. A line of Standard Gauge railroad and a telegraph line commencing at or near the junction of Beaver Creek and Prichard Creek; thence along Beaver Creek, on either bank thereof, to the source of said Beaver Creek, with a branch along Carbor Creek to

the source of said Carbon Creek, all in the State of Idaho; the estimated length of said branch being thirty-five miles; and to maintain and operate such constructed or acquired railroad and telegraph lines and branches and to carry freight and passengers thereon and to collect and receive tolls for the carriage of the same.

Second. To purchase or consolidate with, lease or otherwise acquire, and to operate and maintain on such terms as may be agreed upon, any railroad or railroads in Idaho or Washington with its or their rolling stock, equipments and appurtenances, and to complete the same to its or their authorized terminus or termini and to consolidate with any other railroad company or to lease its lines or any portion of the same to any such railroad company.

Third. To build, purchase, own, lease or operate steamboats upon the Coeur d'Alene River and upon Lake Coeur d'Alene, and to build, purchase and own or lease docks, piers or warehouses for the use of such steamboat lines.

Fourth. To purchase or lease lands, whether adjacent or contiguous to its railroads, docks or warehouses, or not, and to hold, possess improve, lease, sell, mortgage, or otherwise dispose of such lands in such manner as may be deemed fit.

Fifth. To borrow money on bonds, notes, or otherwise, for the general purposes of the corporation, and to mortgage its railroads, steamboats, franchises, rolling stock and any and all property to secure the payment thereof.

Sixth. The above enumeration of purposes shall not exclude any power or authority granted or permitted such corporation under and by virtue of the constitution and laws of the State of Idaho; but this corporation shall have and possess power and authority to do any and all the things necessary granted or permitted railroads and telegraph corporations under said constitution and laws.

Seventh. To do all other things necessary and proper to the accomplishment of the objects above specified.

### ARTICLE III.

The place where the principal business of the corporation is to be transacted is Boise City, County of Ada, State of Idaho.

### ARTICLE IV.

The term for which the corporation is to exist is fifty years from the date of the filing of these articles.

### ARTICLE V.

The number of the directors of the corporation shall be five and the following persons residing at the places indicated are hereby appointed directors of the corporation for the first year, to-wit:

### ARTICLE ~~III~~ VI.

The amount of the capital stock of the corporation shall be two million five hundred thousand dollars (\$2,500,000.00) and the amount of each share of such capital stock shall be One hundred dollars (\$100.00)

### ARTICLE VII.

The capital stock of the corporation has been subscribed by the persons and in the amounts hereinafter set forth, to-wit:


