ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION OF
MANAGEMENT LEASING CORPORATION II

Pursuant to the provisions of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Management Leasing Corporation II.

SECOND: The following Amendment to the Articles of Incorporation was adopted by the shareholders and directors of the corporation by written action and consent dated March 21, 1984, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, That Article I of the Articles of Incorporation of Management Leasing Corporation II, an Idaho corporation, be amended to read as follows:

"The name of the corporation is BASIC TRAINING, INC."

BE IT FURTHER RESOLVED, that Article IV of the Articles of Incorporation of Management Leasing Corporation II be amended to read as follows:

"The address of the registered office of the corporation shall be 540 Balmoral Drive, Boise, Idaho 83702, and the name of its registered agent at such address is Joanne Stevens."

BE IT FURTHER RESOLVED, That the President and the Secretary of the corporation prepare and file with the Office of the Secretary of State of the State of Idaho Articles of Amendment reflecting the foregoing amendment to the Articles of Incorporation.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 200 and the number of shares entitled to vote was 200 shares.

FOURTH: The number of shares voted in favor of such Amendment was 200 shares, and there were no votes against such Amendment.
