

ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS: That the undersigned, ^{Aug 28}
acting as incorporators of a corporation under the Idaho Business ^{Aug 28}
Corporation Act, adopt the following Articles of Incorporation ^{Aug 28}
for such corporation:

I

The name of the corporation shall be RAIN FOREST LUMBER COMPANY, INC.

II

The term for which said corporation shall exist shall be in perpetuity.

III

The address of the initial registered office of this corporation in the state of Idaho shall be 300 First Security Building, Boise, Idaho 83702, and the name of the initial registered agent at that address shall be MTB&B Service Company.

IV

The purposes for which this corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

The business of this corporation shall be managed and conducted by a board of directors. The aggregate number of shares which this corporation shall have authority to issue shall be 10,000 shares of nonassessable, common stock having a par value of \$0.01 per share.


