ARTICLES OF INCORPORATION OF
A D RANCH, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, on this 26th day of September 1980, do hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is A D RANCH, INC.

ARTICLE II

The period of the corporation's duration is perpetual.

ARTICLE III

The purpose for which the corporation is organized is the purchase and sale of land and timber, and any and all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is FIFTY THOUSAND SHARES (50,000) with a par value of ONE DOLLAR (\$1.00) per share, common stock.

ARTICLE V

The address of the initial registered office of the corporation is 301 North 1st Street, Coeur d'Alene, ID 83814 and the name of its initial registered agent at such address is Harold Damiano.

ARTICLE VI
