## CHERRY HILLS, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes herein-after stated pursuant to the Business Corporation Act of the State of Idaho, do hereby certify as follows:

## I.

The name of this corporation is: Cherry Hills, Inc.

## II.

The purposes for which this corporation is formed are:

(a) To engage in a general farming and farm operation business.

(b) To acquire, own and operate farms and farming properties of every kind and nature and wherever situated, and to conduct all phases of farming operations.

(c) To conduct the business of purchasing, raising, feeding and selling livestock and animals of any type and description.

(d) To carry on the business of slaughtering livestock and animals of every type and description for the purpose of food, and to dispose of the products thereof; and to purchase, sell and deal in meats, provisions and all classes of produce and packing house products.

(e) To purchase, acquire, own, sell, market (either as principal or agent) or dispose of farm crops, farm produce, dairy products, poultry products, fruit, vegetables, livestock and meat of every kind and description.

(f) To establish and operate warehouses for the storage of any commodity and all type of goods, wares and merchandise, including cold storage, refrigeration and food preservation and processing facilities.

(g) To establish, maintain and conduct merchandising activities of every kind or nature through which goods, wares and merchandise of every kind and description are bartered, exchanged, sold or dealt in.

(h) To purchase, acquire, own, hold, lease (either as lessor or as lessee), sell, exchange, subdivide, mortgage, and generally operate any real or personal property of any and every kind or description, within or without the State of Idaho, necessary, suitable or useful in connection with any of the objects or purposes herein set forth.

(i) To construct and erect buildings or structures upon and to improve and maintain any and all real property owned, leased or held by this corporation; and to equip, improve and generally operate any and all personal property owned by this corporation.

(j) To purchase, hold, sell and transfer the shares of its own capital stock; provided, it shall not use its funds or property for the purchase of its own shares of capital stock when such use would cause any impairment of its capital; and provided further that the shares of its own capital stock owned by it shall not be voted upon directly or indirectly.

1 (p) To carry out all or any part of the foregoing objects,  
2 or purposes as principal or agent, or otherwise, either alone or in  
3 conjunction with any person, association or other corporation and  
4 in any part of the world; and in carrying on its business and for  
5 the purpose of attaining or furthering any of its objects or purposes,  
6 to make and perform such contracts of any kind and description, to  
7 do such acts and such things and to exercise any and all such powers  
8 as a natural person could lawfully make, perform, do or exercise,  
9 provided that the same be not inconsistent with the objects or pur-  
poses of this corporation, or the statutes of the State of Idaho.

6 (q) To conduct its business in all or any of its branches  
7 in the State of Idaho and in any and all other states, territories,  
8 possessions, colonies and dependencies of the United States of  
9 America, and in the District of Columbia, and in any or all foreign  
countries, and to have one or more offices within or outside of the  
State of Idaho.

10 (r) The objects as specified herein shall, except as  
11 otherwise expressed, be in no way limited or restricted by reference  
12 to or inference from the terms of any other clause or paragraph of  
13 these articles. The objects, purposes and powers specified in each  
14 of the clauses or paragraphs in these articles shall be regarded as  
15 independent objects, purposes and powers.

13 The foregoing shall be construed as objects and powers and  
14 the enumeration thereof shall not be held to limit or restrain in  
15 any manner the general powers now or hereafter conferred on this  
corporation by the statutes of the State of Idaho.

### III

17 The period of existence and the duration of the life of  
this corporation shall be perpetual.

### IV

19 The location and post office address of the registered of-  
20 fice of this corporation in the State of Idaho shall be Route #6,  
21 Caldwell, in the County of Canyon, State of Idaho.

### V

22 This corporation is authorized to issue one class of shares  
23 of its capital stock to be designated as "Common Stock". The total  
24 number of shares of common stock which this corporation shall be  
25 authorized to issue is 1000. The aggregate par value of the common  
26 capital stock of this corporation shall be \$100,000.00; and the par  
27 value of each share of said common capital stock shall be \$100.00.

A director of this corporation shall not be required to be a holder of any of the shares of the common capital stock of the corporation.
