

Articles of Incorporation of the
Settlers' Land and Water Co. Limited

I know All Men By These Presents:-

That, we the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:-

1. That the name of said corporation is the "Settlers' Land and Water Company," Limited.
2. That the purposes for which it is formed are the irrigating and reclaiming of a tract of 9,800 acres or such a part thereof as our water supply, when fully developed, will irrigate and reclaim, said tract of land being located in Twp. 16 S., R. 27 E. B. M.
3. That the place where its principal business shall be transacted shall be the town of Haf, Cassia County - Idaho.
4. That the term for which said corporation is to exist - from and after its incorporation shall be fifty years.
5. That the number of its directors shall be ~~five~~^{six}, and its directors chosen to serve

for the first fiscal year are, Robert Williams, Samuel Kent, Joe Sorensen, Randolph Lee, David Jones and Edmund Walters, all of Nag S doho.

6. That the amount of capital stock of this corporation shall be Twenty-Five Thousand Dollars, divided into Two Hundred and Fifty shares of the value of One Hundred Dollars each.

7. That the amount of capital stock which has actually been subscribed is Ten Thousand dollars, and the following are the names of the persons by whom the same has been subscribed, to-wit:


