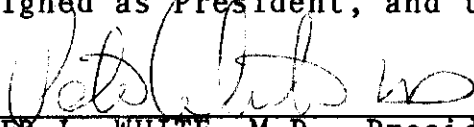
4. All debts, obligations, and liabilities of the corporation have been paid and discharged.
