ARTICLES OF INCORPORATION  
OF  
ST. MARIES LOGGERS RADIO ASSOCIATION, INC.  
(a non-profit corporation)

The undersigned, acting as incorporators of a non-profit corporation under the Idaho Non-profit Corporation Act, adopt the following Articles of Incorporation for such non-profit corporation:

FIRST: The name of the non-profit corporation is St. Maries Loggers Radio Association, Inc.

SECOND: The Corporation is a non-profit corporation organized pursuant to the Idaho Non-profit Corporation Act.

THIRD: The period of its duration is perpetual.

FOURTH: The purposes for which this corporation is formed are as follows:

(a) To foster the development of radio communications in private forest industries and coordinate and correlate such activities with those of private, public and conservation agencies.

(b) To aid and assist members in the development and use of private two-way radio communication systems and to collect, exchange and disseminate information to all members of the corporation.

(c) To promote forest safety and fire protection, control and suppression in the forest industries by means of radio communication and cooperation among the members of this corporation.

(d) To provide qualified representation to cooperate with other agencies using radio communications including without limitation, the U.S. Forestry Service, the Bureau of Land Management, the Division of Forestry of the State of Idaho, together with all governmental agencies.

(e) To apply for membership and to become a member of any other corporation, association or group concerned with industrial forest communications and to cooperate with its aims and purposes to the extent consistent with the aims and purposes of this corporation.

(f) To acquire, construct, lease, maintain and operate stations and facilities for transmitting and receiving radio communication and messages of all kinds and descriptions.

(g) To engage in any lawful activity for which non-profit corporations may be organized under the laws of the State of Idaho.

(h) To acquire, hold, own, use and dispose of, in any legal manner, all real and personal property whatsoever, as may be reasonably necessary for the purpose of carrying into effect any one or more of the objects herein mentioned, and mortgage, hypothecate, pledge, sell and otherwise dispose of said property; to borrow money and to do all acts, and make, execute and deliver all necessary instruments for carrying on of the said purposes; to enter into contracts, to borrow money, lend money and to evidence the indebtedness of the corporation by notes, bonds or other instruments and to secure the same by pledge, mortgage, trust deed or other instruments as to the corporation may seem proper.

(i) To have and exercise all the powers and authority and to engage in all activities now or hereafter allowed by law to non-profit corporations of the State of Idaho.

FIFTH: The address of the initial registered office of the non-profit corporation is Route 3, St. Maries, Idaho, 83861, located three miles East of St. Maries, Idaho on the St. Joe Road, and the name of the non-profit corporation initial registered agent is Robert Russell.




