ARTICLES OF INCORPORATION

OF

COTTONWOOD ELEVATOR COMPANY, INC.

The undersigned, acting as the incorporators of a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is:
COTTONWOOD ELEVATOR COMPANY, INC..

SECOND: The period of the corporation's duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 200,000 shares of common stock, each having a par value of \$1.00 per share, for a total authorized capitalization of \$200,000.

FIFTH: The address of the initial registered office of the corporation is 99 Broadway Street, P.O. Box 125, Cottonwood, Idaho 83522, and the name of the initial registered agent at such address is WALTER RUHOFF.
