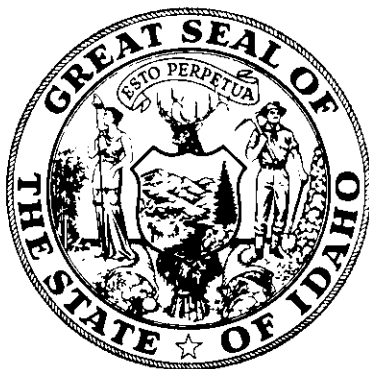

ARTICLES OF INCORPORATION
OF
WEYYAKIN INC.

The undersigned, acting as incorporators under the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

NAME

The name of the corporation is Weyyakin Inc.

DURATION

The period of its duration shall be perpetual.

PURPOSES

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

STOCK

The Corporation shall have the authority to issue ten thousand (10,000) shares of capital stock, all of one (1) class, with each share having a par value of TEN & 00/100 DOLLAR (\$10.00).


