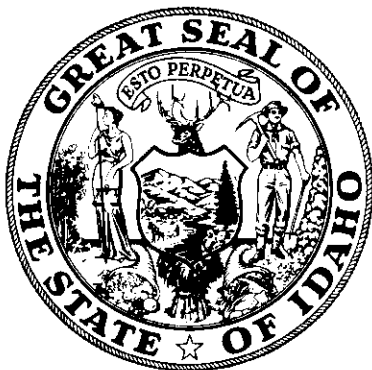

WE, THE UNDERSIGNED, acting as incorporators under the Idaho Non-Profit Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I.

THAT the name of this corporation is and shall be YOUTH FOR A BETTER WORLD, LTD.

ARTICLE II.

THAT the corporation herein is a non-profit charitable and educational corporation as defined in the Idaho Non-Profit Corporation Act.

ARTICLE III.

THAT the duration of this corporation is perpetual.

ARTICLE IV.

THAT this corporation is organized so that youths may have the opportunity to improve world conditions.

ARTICLE V.

THAT the corporation shall have members as defined by the board. Members shall have full voting rights at all membership meetings, said rights being limited to one (1) vote per person.

ARTICLE VI.

THAT the Board of Directors shall consist of neither less than three (3) nor more than nine (9) members.

ARTICLE VII.

THAT the Board of this corporation is empowered to amend, alter, repeal, or adopt new bylaws for the corporation.

ARTICLE VIII.

THAT in addition to those powers granted by the Idaho Non-Profit Corporation Act, the Corporation shall be empowered to accept tax deductible donations with all net income being used to promote the purpose of the corporation.

ARTICLE IX.

THAT no part of the net earnings of this corporation shall insure the benefit of, or be distributed to its members, officers, or board members.
