ARTICLES OF AMENDMENT

TO ARTICLES OF INCORPORATION OF

ROCK ROAD SPRINKLER IRRIGATION CORPORATION

BE IT REMEMBERED, That at a legally called special meeting of the shareholders of ROCK ROAD SPRINKLER IRRIGATION CORPORATION held at the place of business of said corporation in Driggs, Teton County, Idaho, on the 20th day of July, 1966, which meeting, as will hereinafter more particularly appear from the affidavit of the President and Secretary of the corporation hereto attached, was legally called for the specific purpose among other things of submitting to the shareholders of said corporation the question of the adoption of amendments to the Articles of Incorporation of said corporation hereinafter specified, at which meeting a quorum of 411.08 shares of a total of 411.08 shares of the outstanding stock of said corporation were represented either in person or by proxy; and by the affirmative vote of 411.08 shares out of a total of 411.08 shares of stock there represented in person or by proxy, a resolution was passed and adopted, amending the Articles of Incorporation as follows:

"ARTICLE SIXTH of said Articles of Incorporation is amended to read as follows:

'The total number of shares which may be issued by the corporation is 1313.08, representing one share for each acre of land within the corporation's system, all of which stock is for no nominal or par value. The ownership of said stock shall be limited and shall be held and transferred as provided for in the By-Laws. The land to be included within the corporation's system shall be specified, also, in the By-Laws. At all meetings of the stockholders, each stockholder may vote by written proxy.'"

"ARTICLE SEVENTH of said Articles of Incorporation is amended to read as follows:

'The total number of shares of the capital stock of this corporation which have been actually subscribed and paid for is the sum of 1313.08, and following are the names of the persons or entities, their mailing addresses and the number of shares each has subscribed for, to-wit;

Each of the above named persons is also a stockholder hereof, and each one is advised and knows of the general plans of the corporation, and particularly consents that the corporation will immediately borrow from the United States of America, Farmers Home Administration sufficient monies to acquire and install the pipeline system, and all loans, together with the ordinary expenses of maintenance and operation of the system shall be paid by assessments upon the capital stock of the corporation, to be levied and collected in a manner provided for in the By-Laws of this corporation. That Boyd Moulton is the President and Stanley Nelson is the Secretary of ROCK ROAD SPRINKLER IRRIGATION CORPORATION, a corporation organized and existing under and by virtue of the laws of the State of Idaho since April 6, 1964, the date of its incorporation; that the foregoing amendment to the Articles of Incorporation of said Rock Road Sprinkler Irrigation Corporation was adopted by the affirmative vote of 411.08 shares of the 411.08 shares of outstanding stock of said corporation at a special meeting of the shareholders held at the office of said corporation in Driggs, Teton County, Idaho, at the hour of 8 o'clock p.m. on the 20th day of July, 1966; written notice of said special meeting, stating the purpose thereof, was given to all shareholders
