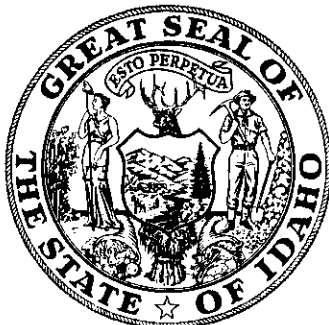
CERTIFICATE OF WITHDRAWAL OF
