- C. Compensation of Directors. The Board of Directors shall not receive compensation for their services as Directors. A Director may serve the Corporation in any other capacity and may receive compensation for such services rendered in any form.

D. <u>Contracts in which Directors Have an Interest</u>. The Bylaws of the Corporation shall provide for the handling of contracts or transactions in which Directors may have a financial interest,

whether direct or indirect.

E. Indemnification of Directors and Officers. The Bylaws of the Corporation shall

provide for the circumstances in which Directors and Officers of the Corporation may be entitled to

indemnification.

X. AMENDMENT OF ARTICLES OF INCORPORATION.

These Articles of Incorporation may be amended in any respect conformable to the laws of

the State of Idaho by an affirmative vote of more than seventy-five percent (75%) of the

Shareholders entitled to vote in a meeting of Shareholders called for such purpose as prescribed by

law.
