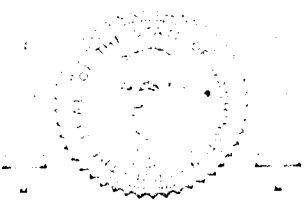

ARTICLES OF AMENDMENT
OF
BUSINESS FINANCE CO., INC.

KNOW ALL MEN BY THESE PRESENTS that by resolution on the 28th day of November, 1966, the following amendment to the Articles of Incorporation of BUSINESS FINANCE CO., INC., a Washington Corporation, was duly adopted:

FOURTH:

The authorized capital stock of the corporation shall be \$250,000.00, consisting of 250,000 shares of common stock having a par value of \$1.00 each.
