ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF
EAST SIDE CABINET CO.

Paragraph I of the articles of incorporation of the East Side Cabinet Co., is hereby amended to read as follows:

"I. The name of this corporation shall be Grimmett Building & Supply Company."

Paragraph II of the said articles of incorporation is hereby amended by adding the following sub-paragraph thereto:

"H. To buy and sell, at either wholesale or retail, and to manufacture, install and repair, all kinds of lumber and millwork, electric fixtures, appliances, motors, materials and supplies, including refrigerator and refrigerator plants, radio and television machines, supplies and equipment; also all kinds of heating, plumbing and air-conditioning units and supplies; automobiles, trucks, trailers, trailer-houses; boats, motors, pre-fabricated houses and buildings, building units of all kinds, furniture and household furnishings, sporting goods, tents, awnings, glass, tiles and ceramics of all kinds; and to buy and sell, at either wholesale or retail, all kinds of paints, wall paper, painters' equipment, tools and supplies; also all manner of hardware, tools, implements and roofing materials, together with any article or product even remotely related to those expressly enumerated herein."
