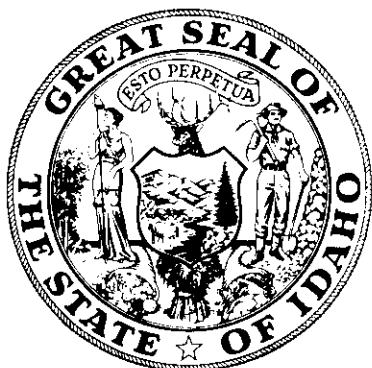

## ARTICLES OF INCORPORATION

OF

CENTURY DESIGN, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is CENTURY DESIGN, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

A. Construction and design.

B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 100. Said shares shall consist entirely of one class of common stock with each share having a par value of \$1.00. No distinction shall exist between the shares of this corporation, and all such shares shall have the same rights in such corporation, and shall be non-assessable when paid in full.

FIFTH: The address of the initial registered office of the corporation is 2005 Ironwood Parkway, Suite 138, Coeur d'Alene, Idaho, and the name of its initial registered agent at such address is CRAIG R. WISE, Attorney at Law.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
