ARTICLES OF INCORPORATION

OF

SPEEDWAY SIGNS, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of legal age, and citizens of the United States, do hereby associate ourselves together with the purpose of forming a corporation under the provisions of the laws of the State of Idaho, and do hereby adopt the following Articles of Incorporation, to-wit:

I.

The name of the corporation shall be SPEEDWAY SIGNS, INC.

II.

The nature, objects and purposes for which this corporation is formed shall be:

a. To conduct an advertising business both as principals and agents, including the preparation and arrangement of advertising in connection with luminous advertising. To transact the business of advertising, promoting, and developing the business of other corporations, partnerships, or individuals for hire, or upon commissions, or otherwise, by the use of luminous advertising, and to so advertise all types and kinds of commodities, products, or other property, real, personal, or mixed, of other corporations, partnerships, or individuals.

b. To transact the business of advertising, promoting, and developing the business of other corporations, partnerships, or individuals for hire, or upon commission, or otherwise, by and through the means of preparing advertising for other corporations, partnerships, or individuals, and of advertising the business, commodities, or other property, real, personal, or mixed, of other corporations, partnerships, or individuals in newspapers, books, booklets, prospectuses, magazines, circulars, pamphlets, or other similar literature and advertising media.

c. To carry on the business of manufacturers of all kinds of apparatus, appliances, plant, and material employed by advertising contractors in their business.

d. To engage in the business of promoting, selling, and distributing advertising material, decalcomania transfers, signs, advertising displays, adhesive signs, adhesive stickers, adhesive display markers, and all similar and related commodities.

e. To manufacture, buy, sell, and otherwise dispose of at either wholesale or retail, import, and export, and generally trade in and deal with electric light advertising displays, signs, advertisements, and advertising devices and novelties, and to manufacture, buy, sell, store, market, prepare for market, and generally deal in and trade with any articles or things of every nature and description.

To manufacture, take, produce, contract for, purchase, lease, or otherwise acquire, own, hold, use, mortgage, pledge, sell, lease, exchange, assign, or transfer or otherwise hypothecate or dispose of, to invest, trade, and generally deal in and with tubes, lamps, materials, apparatus, appliances, equipment, machines, and devices of any and all kinds for the purpose of producing or creating illumination and for any other purpose whatsoever, and generally to operate, engage in, and conduct any such business.

f. To buy, sell and deal in all kinds of contracts, notes, bills of sale, mortgages and other evidences of debt, and the security for the payment of the same; to discount or negotiate notes, bills and other evidence of debt; to buy, sell, own and hold shares of capital stock of corporations, including this corporation.

g. To acquire by purchase, subscription or otherwise, and to hold and hypothecate, and to dispose of stocks, bonds, or any other obligation of all kinds; and to sell, trade in and exchange the same, and all classes of stocks, bonds, notes, bills of sale and other securities.

h. To buy, hold, purchase, contract for, own, sell, mortgage, lease, or exchange real or personal property of all kinds, including motor vehicles, of all kinds.

i. To carry into effect the object and purpose aforesaid, this corporation is authorized to do all and singular the things, necessary and convenient to carry out the general purposes for which it is organized.

j. To transact the business of advertising, promoting, and developing the business of this corporation and other corporations, partnerships, or individuals for hire, or upon commission, or otherwise, by and through the means of preparing advertising for this corporation and other corporations, partnerships, or individuals, and of advertising the business, commodities, or other property, real, personal or mised, of other corporations and their corporation, partnerships, or individuals in newspapers, books, booklets, prospectuses, magazines, circulars, pamphlets, including radio, T.V., billboards, brochures, newspapers, or other similar literature and advertising media.

k. All the foregoing provisions of this Article II are to be construed both as objects and powers, and it is hereby expressly provided that the enumeration herein of specific powers and objects shall not be held to limit or restrict in any manner the general purposes and powers of the corporation; provided, however, that nothing herein contained shall be deemed to authorize or permit the corporation to carry on any business or to exercise any power to do any act which a corporation formed under the laws of the State of Idaho now or hereafter existing may not, at all time, lawfully carry on or do. It is the intention that the purpose, objects and powers specified in each of the paragraphs of this Article II shall, except as otherwise provided, in no wise be limited or restricted by reference to or inference from the terms of any other clause or paragraph in these Articles contained or of any other provisions of these Articles of Incorporation.

III.

The duration of this corporation shall be perpetual.

IV.

The location and post office address of the registered office of this corporation is and shall be Meridian, Idaho.

V.

The total authorized number of shares which may be issued by this corporation is One Hundred shares of common stock with a par value of Fifty (\$50.00) Dollars, per share, and non-assessable, for a total capitalization of \$5,000.00.

VI.

All shares of this corporation are the same class with equal rights and voting power and without preference or priority of any share over any other share.

VII.
