ARTICLES OF INCORPORATION OP . K. I. C., INC.

The undersigned, a natural person of the age of 21 years or more, for the purpose of forming a corporation under the laws of the State of Washington and in pursuance thereof does hereby sign and deliver in duplicate to the Secretary of State of the State of Washington the following Articles of Incorporation and states as follows:

ARTICLE I.

The name of the corporation shall be K. I. C., INC.

ARTICLE II.

The period of its duration is perpetual.

ARTICLE III.

The purposes for which the corporation is organized are:

- 1. To engage in any form of construction, contracting, manufacturing, mercantile, financial, transportation, real estate, recreation or service, business or enterprise not contrary to law.
- 2. Without limiting the generality of the foregoing, to engage in the investment in and development of real estate.

ARTICLE IV.

The aggregate number of shares which the corporation shall have authority to issue is 500, with each of such shares having a par value of \$100.00.

ARTICLE V.

The corporation shall not commence business until at least \$500.00 has been received by it as consideration for the issuance of shares.

ARTICLE VI.

The address of the initial registered office of the corporation is:

ARTICLE VII.

The number of Directors constituting the initial Board of Directors is one (1), and the name and address of the person who is to serve as Director until the first annual meeting of shareholders or until her successor or successors be elected and qualify is:

ARTICLE VIII.

- 1. The corporation will offer only common stock qualifying as Section 1244 stock as defined in Section 1244 of the Internal Revenue Code during a period ending two (2) years from the date of incorporation.
- 2. The maximum amount to be received by the corporation in consideration for the stock to be issued pursuant to the plan shall be \$50,000.00.
- 3. No shares offered under this plan shall be issued in exchange for stocks, securities or services rendered.

ARTICLE IX.

The power to adopt, alter, amend or repeal the By-Laws or adopt new By-Laws shall be vested in the Board of Directors.
