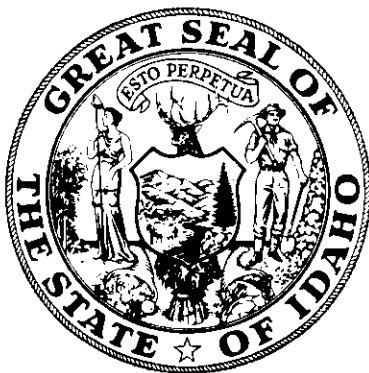

ARTICLES of INCORPORATION

OF

POWER TECHNOLOGIES INC.

A CLOSE CORPORATION

FIRST. The name of the corporation is POWER TECHNOLOGIES INC.

SECOND. Its registered office in the state of Idaho is to be located at BOX 3244 KETCHUM, IDAHO 83340, in the county of BLAINE. The registered agent in charge thereof is RICHARD FLICKINGER with address same as above.

THIRD. Its period of duration is perpetual.

FOURTH. The purpose or purposes for which this corporation is organized shall include the transaction of any and all lawful business for which corporations may be incorporated under the general corporation laws of the state of Idaho.

FIFTH. The amount of total authorized capital stock of the Corporation is divided into 1000 shares of NO PAR VALUE.

SIXTH. All of the Corporation's issued stock shall be held by no more than twenty (20) persons.

SEVENTH. All of the issued stock of the Corporation shall be subject to the following restriction:

Each stockholder shall offer to the Corporation or to other stockholders of the Corporation a thirty (30) day "first refusal" option to purchase his stock should he elect to sell his stock.
