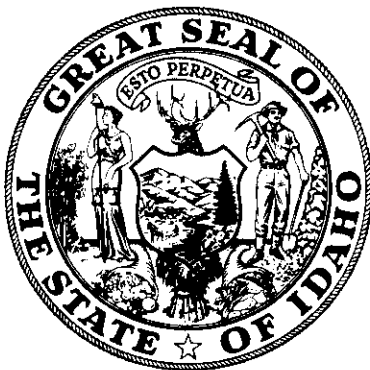

## ARTICLES OF INCORPORATION

THE UNDERSIGNED incorporators desiring to form a nonprofit corporation, pursuant to the provisions of the Idaho Nonprofit Corporation Act and the Idaho Business Corporation Act, adopt the following articles of incorporation:

### Article One - Name

The name of this religious corporation is Bovill Community Presbyterian Church, Incorporated.

### Article Two - Status

The corporation is a nonprofit religious corporation.

### Article Three - Purpose

The purpose for which this corporation is organized shall be to establish and maintain a church and to provide a place of public worship and prayer in accordance with the traditions of the Presbyterians in the city of Bovill, County of Latah, State of Idaho; to buy, sell, lease, mortgage or therewith encumber, hold, or dispose of both real and personal property of the corporation in accordance with the governing rules of the United Presbyterian Church in the United States of America; to further all religious and charitable work; and for such purpose to adopt and establish by-laws, rules, and regulations in accordance with law and not inconsistent with this article of incorporation.

### Article Four - Place of Worship

The initial registered office in the State of Idaho is City of Bovill, State of Idaho, and the name of the corporations initial registered agent at such address is Steve Hammond, Bovill, Idaho.

### Article Five - Duration

The period of duration of this corporation is perpetual.

#### Article Six - Nonstock Corporation

This corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

#### Article Seven - Elders

The number of elders constituting the initial board of elders of the session is six, and the names and addresses of the persons who are to serve as elders until the first annual meeting of the members or until their successors are elected and qualify are:

#### Article Eight - Election of Elders

At an annual meeting of the members, Elders shall be elected by a majority vote of the members entitled to vote and actually present and voting for a term consistent with the provisions of Article        of the by-laws to succeed the two (2) Elders whose terms then expire; provided that nothing herein shall be construed to prevent the election of an Elder to succeed himself. The election of Elders shall be by secret ballot.

The term of each Elder shall commence immediately upon his/her election.

#### Article Nine - Membership

The members of this corporation shall consist of the persons as provided by Article One of the By-laws.

#### Article Ten - By-laws

By-laws not inconsistent with the Article of Incorporation

and in conformity with the Constitution of the United Presbyterian Church in the United States of America may be adopted, altered, amended or repealed at any regular meeting of the members, or at any special meeting of the members of the corporation called for that purpose, by the affirmative vote of two-thirds (2/3) of the members present at such meeting; provided, however, a quorum, which shall be as defined in the Idaho Nonprofit Corporation Act, shall be present through members and not by proxies.

#### Article Eleven - Amendments

That the Articles of Incorporation of this corporation may be altered or amended at any regular meeting of the members of any special meeting of the members called for that purpose by an affirmative vote of two-thirds (2/3) of the members present at such a meeting; provided written notice of the intention to amend the Article of Incorporation is served on each and all of the members in accordance with the Idaho Nonprofit Corporation Act.
