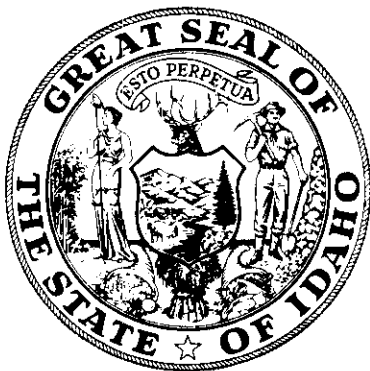

Fourth: A notice required by Section 30-1-87, Idaho Code was given.

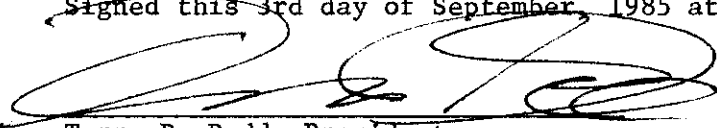
Fifth: All debts, obligations and liabilities of the corporation have been paid and discharged, or adequate provision has been made therefor.

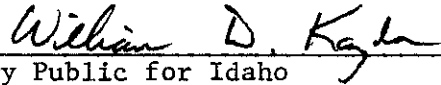
