OF

KNOW ALL MEN BY THESE PRESENTS, THAT WE, THE UNDERSIGNED BEING NATURAL PERSONS OVER THE AGE OF EIGHTEEN (18) YEARS, DO HEREBY FORM A GENERAL BUSINESS CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO AS CONTAINED IN TITLE 30 OF THE IDAHO CODE ENTITLED "GENERAL BUSINESS CORPORATION ACT", AND TO THAT END DO HEREBY SET FORTH:

1. THE NAME OF THE CORPORATION IS: TRANSPORTATION SERVICES, INC.

2. THE PERIOD OF DURATION OF THIS CORPORATION SHALL BE PERPETUAL.

3. THE PURPOSES FOR WHICH THIS CORPORATION IS ORGANIZED:

(A) PRIMARILY TO ENGAGE IN THE BUSINESS OF OPERATING A FINANCIAL AND RISK MANAGEMENT SUPPORT FOR THE TRANSPORTATION INDUSTRY.

(B) THE TRANSACTION OF ANY OR ALL LAWFUL BUSINESS FOR WHICH CORPORATIONS MAY BE INCORPORATED UNDER THE IDAHO BUSINESS CORPORATION ACT.

4. THE COUNTY IN THE STATE OF IDAHO WHERE THE PRINCIPAL OFFICE FOR THE TRANSACTION OF BUSINESS OF THE CORPORATION IS LOCATED IS IN THE COUNTY OF BANNOCK AND THE NAME OF THE REGISTERED AGENT IS ROY F. MILLER, JR., AND THE ADDRESS OF THE REGISTERED OFFICE SHALL BE 755 WEST CENTER, POCA TELLO, IDAHO 83201.

5. THE AGGREGATE NUMBER OF SHARES WHICH THE CORPORATION SHALL HAVE AUTHORITY TO ISSUE IS 1,000, HAVING A PAR VALUE OF \$1.00 PER SHARE. ALL OF SAID STOCK SHALL BE KNOWN AS COMMON STOCK AND SHALL BE NONASSESSABLE.

7. THE DIRECTORS OF THE CORPORATION SHALL HAVE THE POWER TO SELL ANY AUTHORIZED BUT UNISSUED STOCK AT ANY TIME AND TO ANY PERSON, AND NO STOCKHOLDER SHALL BE ENTITLED, AS OF RIGHT, TO SUBSCRIBE FOR OR PURCHASE OF ANY OF SUCH ADDITIONAL SHARES OF STOCK.

8. THE NUMBER OF DIRECTORS OF THE CORPORATION MAY BE FIXED BY THE BY-LAWS, BUT SHALL NOT BE LESS THAN THE NUMBER REQUIRED BY LAW.

THE NUMBER OF DIRECTORS CONSTITUTING THE INITIAL BOARD OF DIRECTORS SHALL BE TWO (2), AND THEY SHALL SERVE AS DIRECTORS UNTIL THEIR SUCCESSORS ARE ELECTED AND QUALIFIED.
