*RE: Use of the Word "Bank" in Company Name in Idaho*

Dear Ms. Watson:

The Idaho Department of Finance (Department) received your email on June 22, 2021. In this email, you request an approval letter from the Department to file with the Idaho Secretary of State to register and use the business name "Commerce Bank." In your email, you indicated that one of Commerce Bank's employees will be moving to Idaho and will continue to work remotely for the company. We further understand from you that Commerce Bank is a trust company and that the employee will not be soliciting business in Idaho but will be working on existing home equity lines of credit. You also provided a copy of a Certificate of Corporate Good Standing, Charter No. 345T, which was issued by the State of Missouri, Division of Finance for Commerce Bank.

Idaho Code § 26-1202 of the Act provides that "no person may advertise or transact business in this state under a name or title that contains the word 'bank,' 'banker,' 'bancorp,' 'savings bank,' 'trust company,' or a word or words of similar import, unless the person has been granted a charter to engage in banking or trust business in this state by the director, or unless the director has granted the person a waiver from this prohibition as set forth in this section. However, Idaho Code § 26-1202(2) states that the "prohibition shall not apply to a ... state-chartered bank or trust company located in another state that has obtained all approvals that may be required under the law as a prerequisite to doing business in this state." Since the statute does not apply to a state-chartered bank, there is no need for the Director of the Department to grant a waiver to a state-chartered financial institution to use the word "bank" in its name in Idaho. Under these circumstances, the Department offers "no objection" to Commerce Bank's use of the word "bank" in its name and to registering to do business in Idaho.
