ARTICLES OF INCORPORATION OF

THE FLIGHT LINE, INC.

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is THE FLIGHT LINE, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to sell, lease, service, maintain and repair aircraft; sell aviation fuel; provide charter and flight instructional services plus any other thing for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is Burley Municipal Airport, Burley, Idaho, 83318, and the name of its initial registered agent at such address is Tim Charles.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is three, and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected shall qualify are:


