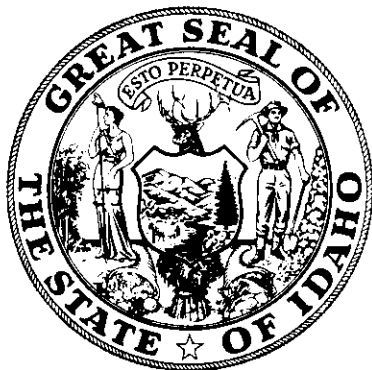

ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
SOUTH FORK ELECTRONICS, INC.

South Fork Electronics, Inc., an Idaho corporation, by its sole shareholder, B. Joyce Wickham, hereby submits to the Secretary of State of Idaho, Corporations Division, these Articles of Amendment to Articles of Incorporation of said corporation, pursuant to I.C. §30-1-61.

1. The name of the corporation is South Fork Electronics, Inc.

2. The amendment adopted by the sole shareholder is to Article III, which shall be amended to read in its entirety as follows:

"The duration of the existence of this Corporation shall be from the date of incorporation to July 1, 1987."

3. The date on which the above amendment was adopted by the sole shareholder was June 23, 1987.


4. The number of shares outstanding, and the number of shares entitled to vote thereon, was 50 shares. None of such shares were entitled to vote thereon as a class. The number of shares voted for and against such amendment, respectively, was 50 and 0.

5. Such amendment does not provide for an exchange, reclassification, or cancellation of issued shares.

6. Such amendment does not effect a change in the amount of stated capital.


