



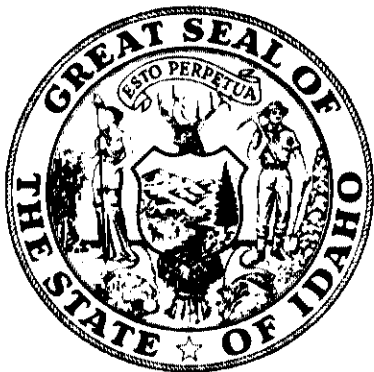

The undersigned parties, desiring to amend the Certificate of Limited Partnership of Barbados No. 2, Ltd., dated November 5, 1982, and filed in the Office of the Clerk of Salt Lake County, State of Utah, do hereby swear and certify as follows:

1. The name of the Partnership is Barbados No. 2, Ltd., a Limited Partnership.

2. The character of the business of the Partnership shall be to engage in the construction and operation of a resort hotel facility.

3. The location of the principal place of business of the Partnership is 4424 South Seventh East, Suite 290, Salt Lake City, Utah 84107.

4. The name and place of residence of the General Partner are as follows:

5. The term for which the Partnership is to exist is until December 31, 2037, or until sooner terminated as provided by law, or as provided by the Agreement of Limited Partnership.

6. The name and place of residence of each Limited Partner and the amount of cash and a description of and the agreed values of the other property contributed by each Limited Partner are set forth in Attachment "A" attached hereto and incorporated herein by this reference.

7. A Limited Partner is not subject to any additional assessment beyond such Limited Partner's initial capital contribution.

8. No Limited Partner has any right to demand the refund or return of his contribution at any specified time. Limited Partners shall not receive a distribution of profits, gains or return of capital until dissolution, termination and winding up of the Partnership.

9. The share of the profits, or the other compensation by way of income, which each of the Limited Partners shall receive by reason of his or her contribution, is proportionate to his or her capital contributions in relation to the contributions of all Partners and subject to certain restrictions and limitations as to amount as set forth in the Agreement of Limited Partnership.

10. Without the prior consent of the General Partner, no Limited Partner has the right to substitute an assignee contributor in his or her place.

11. Additional Limited Partners may be admitted.

12. There is no general right given to one or more of the Limited Partners to priority over any other Limited Partner as to contributions or as to compensation by way of income.

13. Because the General Partner is a corporation, there is no specific provision for any successor or additional general partner and no specific provision for continuation of the business upon the death, retirement or insanity of the General Partner. The Limited Partners are given the right to remove and replace the General Partner, and, in either case, the business of the Partnership would continue. In cases of legal disability of the General Partner, the Limited Partners are required to replace the General Partner and the business of the Partnership would continue.

14. No Limited Partner has the right to demand and receive property other than cash in return for his contribution.
