

**AMENDED ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF THE IDAHO ALLIANCE, INC.**

A meeting of the shareholders of The Idaho Alliance, Inc., an Idaho corporation, was held on the 12th day of April, 1993, at the hour of 12:00 o'clock noon, in accordance with the By-Laws and pursuant to written Waiver of Notice signed by all the directors and members for the purpose of amending the Articles of Incorporation of The Idaho Alliance, Inc.

Upon resolution duly presented, seconded and unanimously carried, the Articles of Incorporation of The Idaho Alliance, Inc., are amended in the following manner:

This corporation is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States

Internal Revenue Law).

Upon winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and or scientific purposes and which has established its tax exempt status under section 501(c)(3) of the Internal Revenue Code.

The foregoing amendment to the Articles of Incorporation was adopted by a vote of 100% of the members and directors of the Corporation at a meeting of all the shareholders of the Corporation held on the 12th day of April, 1993.

Except for the designated amendment, the Amended Articles of Incorporation, together with the Articles of Incorporation, correctly set forth without change the corresponding provisions of the Article of Incorporation as heretofore amended, and that the Amended Articles of Incorporation, together with the designated amendment, supersede the original Articles of Incorporation and all amendments thereto.

These Articles are amended to reflect the following which was voted on in the resolution but not inserted in the final copy of the Articles of Amendment to Articles of Incorporation of the Idaho Alliance, Inc., filed with the Secretary of State April 14, 1993; to-wit:




