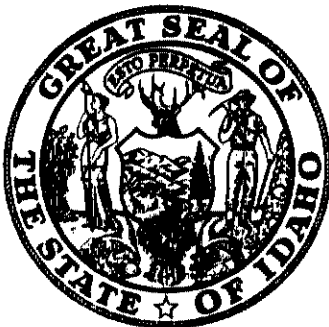
CERTIFICATE OF INCORPORATION OF

The undersigned hereby states the following to form a corporation under the laws of the state of Idaho.

FIRST

The name of the corporation is Dubco Development Corporation.

SECOND

The corporation shall have perpetual duration.

THIRD

The purpose of the corporation is the transaction of all lawful business.

The corporation shall have the authority to issue one thousand (1000) shares of its common stock with a par value of (\$100.00) each. Such stock shall not be assessable for any purpose.


EIGHTH
