ARTICLES OF INCORPORATION
OF

AGRICULTURE, FOREST PRODUCTS AND MANAGEMENT, INC.

KNOW ALL BY THESE PRESENTS:

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation is Agriculture, Forest Products and Management, Inc.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which the corporation is organized are:

To carry on and conduct the business of agriculture and forest brokerage to buy, sell, deal in, lease, rent, and manage agriculture and forest products and any interests therein.

To purchase, improve, develop, lease, exchange, sell, dispose of, and otherwise deal in and turn to account, agriculture and forest products; to purchase, lease, build, construct, erect, occupy, and manage buildings necessary to conduct this corporation; to finance the purchase, improve-

ment, development and milling of agriculture and forest products to be acquired by this corporation, or any other person, firm, or corporation.

To transact the business of investing on behalf of itself or others; to provide the service of estate planning and related counseling; and

To conduct and transact any or all lawful business for which corporations may be incorporated under the Idaho
Business Corporation Act.

IV.

The aggregate number of shares which the corporation shall have authority to issue is TWENTY-FIVE THOUSAND DOLLARS (\$25,000.000) which shall be divided into Twenty-Five Thousand (25,000) shares of common stock, the par value of each share shall be One Dollar (\$1.00), and such stock shall be non-assessable.
