

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The name of the corporation is Caribou Industrial Coatings, Inc.

**SECOND:** The following amendments of the Articles of Incorporation were adopted by the shareholders of the corporation on February 7, 1997, in the manner prescribed by the Idaho Business Corporation Act:


**ARTICLE 9. BOARD OF DIRECTORS:** The number of directors constituting the board of directors of the corporation shall be at least one (1), and not more than five (5). 
