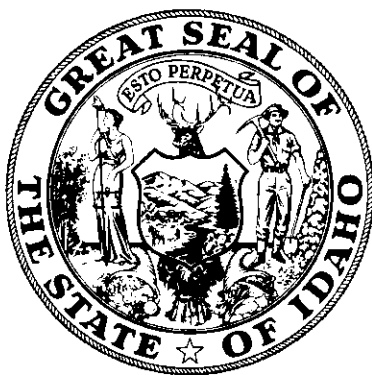

ARTICLES OF INCORPORATION
OF

Article I

The name of this corporation shall be "COMMUNITY PRESBYTERIAN CHURCH, INC. OF MONTPELIER, IDAHO."

Article II

The above named corporation shall be a nonprofit corporation.

Article III

The period of duration of said corporation shall be perpetual.

Article IV

The purpose of said corporation shall be to obtain and maintain a Presbyterian Church affiliated with the General Assembly of the Presbyterian Church (U.S.A.).

Article V

Members of this church corporation entitled to vote at meetings of the congregation shall be those who are active communicant members of the Community Presbyterian Church of Montpelier, Idaho.

Article VI

The location of said church shall be in the city of Montpelier, Bear Lake County, State of Idaho, and its registered office shall be the Community Presbyterian Church building at Hillside Drive and Third Street. Its post office address shall be P.O. Box 271, Montpelier, Idaho, and the name of its initial registered agent shall be Mr. Gary Mills.

Article VII
