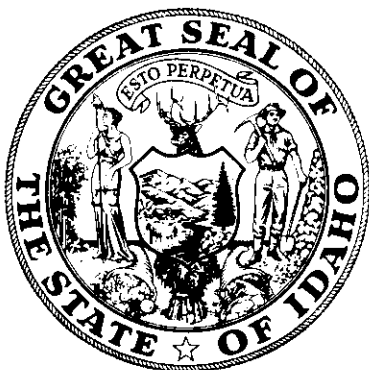

ARTICLES OF INCORPORATION
OF
ATLAS STEEL CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

WE, THE UNDERSIGNED, CLYDE A. BARNEY, RITA H. BARNEY and TAMMA BARNEY, each being at least twenty-one (21) years of age and residents of the State of Idaho, and all being citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, do, under and by virtue of the general laws of the State of Idaho authorizing the formation of corporations, associate ourselves as incorporators with the intention of forming a corporation and do hereby certify as follows:

I.

The name of the corporation shall be:

ATLAS STEEL CORPORATION

II.

The purposes for which this corporation is formed are:

(a) To lease, buy, sell, use, mortgage, improve, repair of otherwise own, operate, handle, deal in, of dispose of steel buildings, metal buildings, prefabricated steel or metal buildings and their component parts.

(b) To hold, own and to acquire for certificates of convenience of necessity, licenses and franchises from state, city, county or federal agencies as required in the furtherance of the corporation's business.

(c) In general, to carry on any other lawful business whatsoever in connection with the foregoing or which is calculated directly or indirectly to promote the interest of the corporation and to enhance the form of its properties and to do all other things necessary for the benefit of the corporation.

III.

The corporation is to have perpetual existence.

IV.

The permanent and registered address of the corporation will be:

V.

The number of directors of the corporation shall be three (3), which shall be increased or decreased pursuant to the By-laws of the Corporation and shall never be less than three (3). The By-laws of the corporation shall provide for a time, manner and place of holding elections. The regulation of the internal affairs of the corporation shall be provided by the By-laws of the corporation.

VI.

The total authorized number par value shares is 10,000 shares. It shall have \$1.00 par value per share.
