
ARTICLES OF INCORPORATION

OF THE

KNOW ALL MEN BY THESE PRESENTS: That we the undersigned ~~men~~ have this day associated our selves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho, and do hereby certify:-

First: That the name of this corporation shall be the Upper Snake River Mining Company, Limited.

Second: That the purpose of this corporation is and shall be to purchase, aquire, hold, bond, lease, work, sell, and convey and operate and locate mines and mining claims and lands; to buy, sell and dispose of mines, mills and other work and works to erect, buy, lease, acquire and operate sampling mills and other mills and plants for the handling, saving, treatment and reduction of ores and metals; to acquire and dispose of water, and water rights and privileges and mill sites for use in connection with such business generally; to conduct and carry on the mining, milling, sampling, smelting and reduction and saving of ores and metals and all that appertains thereto; to acquire patents and construct and manufacture and dispose of and use any machine or machinery useful, or beneficial in the mining business, and all work appertaining or allied thereto; and also to deal in such merchandise as may be to the interest of said corporation.

Third: The place where its principal business is to be conducted and transacted, and its principal office, shall be at Idaho Falls, Bingham County, Idaho,

Fourth: The term for which it is to exist shall be fifty (50) years.


