

ARTICLE II

The name of the registered agent in the State of Idaho is D.H. Sluder and the address of the registered agent is Glendale Rd., Bellevue, Idaho, 83313.

ARTICLE III

The purpose of this Corporation is to engage in any lawful act or Activity for which a corporation may be organized under the General Corporation Law of Idaho.

ARTICLE IV

The amount of stock authorized to be issued is Fifteen Hundred (1500) shares with a par value of One Dollar (\$1.00) per share. Each share of stock shall be common voting stock and shall be entitled to the same dividend liquidation and voting rights.

ARTICLE V

The capital stock of this Corporation, after the amount of the subscription price has been paid in, shall never be assessable, or assessed to pay the debts of the Corporation.

## ARTICLE VI

The members of the governing board of this corporation shall be styled directors and the number thereof at the inception of this Corporation shall be Three (3) or more. The directors need not be shareholders of the Corporation, nor residents of the State of Idaho. The number of directors may from time to time be increased or decreased in such manner as shall be provided by the By-Laws of the Corporation. ## ARTICLE VIII

This Corporation shall be perpetual unless otherwise amended by the Directors.

ARTICLE IX

The Directors shall have the power to make and to alter or amend the By-Laws.

The Stockholders and Directors shall have the power to hold their meetings and keep the books, documents and papers of the Corporation outside the State of Idaho, at such places as may be from time to time designated by the By-Laws or by resolution of the Stockholders and Directors, except as otherwise required by the laws of Idaho.

It is the intention that the objects, purposes and powers specified in Article III hereof shall be nowise limited or restricted by reference to or inference from the terms of any other clause of Article in this Certificate of Incorporation, but that the objects, purposes and powers specified in Article III and in each of the clauses or articles of this charter shall be regarded as independent objects, purposes and powers.
