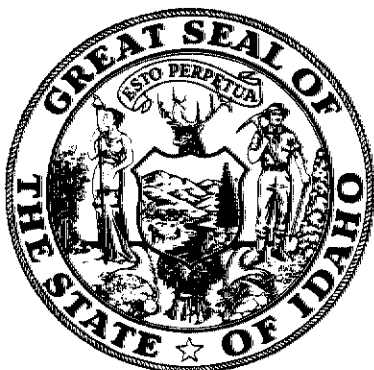

ARTICLES OF INCORPORATION

ETHIOPIAN OUTREACH, INC.

I, the undersigned natural person of the age of 18 years or more, acting as incorporator of a nonprofit corporation under the Idaho General Business Corporations Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be ETHIOPIAN OUTREACH, INC. and the corporation shall be a nonprofit corporation.

ARTICLE II

The nonprofit corporation shall exist perpetually, unless sooner dissolved or disincorporated according to law.

ARTICLE III

The purpose or purposes for which the corporation is organized shall be charitable and to engage in any lawful act or activity for which corporations may be organized in the State of Idaho.

ARTICLE IV

The corporation shall have members and the management of its affairs shall be vested in the membership.

ARTICLE V

The address of the initial registered office of the corporation 122 Board Loop, Warm Springs Road, P. O. Box 2404, Ketchum, Idaho 83340, and the name of its initial registered agent at such address is Mark Stewart.

ARTICLE VI


The number of directors of the corporation shall be two and may be increased or decreased as provided in its bylaws.

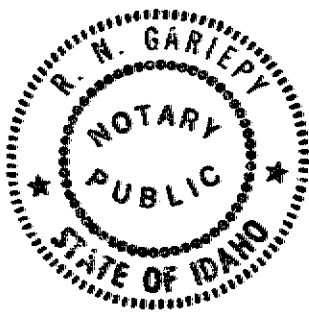
