8 ORDER OF DISSOLUTION.

9 On this the 7th day of July, 1958, there came before the  
10 Court, the matter of the voluntary dissolution of the Commercial  
11 Building Company, an Idaho corporation. It appearing to the Court  
12 that application for dissolution of said corporation was filed with  
13 the Clerk of the above entitled Court, and that notice of applic-  
14 ation for dissolution was published as provided by law and the  
15 order of this Court, which notice was published in the Weiser  
16 Signal, a newspaper of general circulation at Weiser, Washington  
17 County, State of Idaho, and it is found by the Court that due  
18 proof has been made of the publication of the notice of application  
19 for dissolution. Thereupon a hearing was had before the Court and  
20 the Court upon hearing the evidence therein offered in the matter  
21 of the voluntary dissolution of the Commercial Building Company,  
22 an Idaho corporation, and finds that all allegations contained in  
23 the application for dissolution are true and that all debts, claims  
24 and demands of said corporation have been paid, satisfied and  
25 discharged.

26 NOW THEREFORE, it is hereby ORDERED that the Commercial  
27 Building Company, an Idaho corporation, be and the same hereby is  
28 dissolved.

29 It is further ordered that a certified copy of this Decree  
30 declaring the said corporation's dissolution, shall be filed in  
31 the office of the Secretary of State of the State of Idaho, and in  
32 the office of the County Recorder of Washington County, State of

1 Idaho, and with the Recorder of any other County, State of Idaho,  
2 where said corporation may have held or owned real property.
