ARTICLES OF INCORPORATION OF

THE

SCHNEIDMILLER BROTHERS, INC.

We, the undersigned, all of whom are full age natural persons and all of whom are citizens of the United States, do hereby voluntarily associate ourselves for the purpose of forming a Private Corporation under the Laws of the State of Idaho, and do hereby set forth, certify and adopt the following Articles of Incorporation;

I

The name of the proposed Corporation shall be:

Schneidmiller Brothers, Inc.

II

The purposes of the corporation are: to purchase or in any wise acquire for investment or for sale or otherwise, lands, contracts for the purchase or sale of lands, buildings, improvements, and any other real or personal property of any kind, and other terminal properties or facilities, and any property works, waterways or undertakings connected with the use or development of any property of the company wherever located or situated; and to sell, convey, lease, mortgage, or otherwise deal with all or any part of the property of the corporation. To manage, improve, develop any land or contracts for purchase or sale of lands acquired by the corporation, or in which the corporation is interested. To conduct and carry on the business of buying, selling, and dealing in all kinds of grain, hay, or other farm produce; to generally engage in the business of farming and related industries thereto; to engage in any or other enterprise or act that any natural person might or could lawfully do or perform.

III

The duration of the corporation is perpetual.

IV

The location and post office address of the registered office of the corporation in the State of Idaho is Post Falls, Kootenai County, Idaho.

V

The total authorized number of par value shares of stock is Fifty Thousand, (50,000). The aggregate par value of the total authorized number of par value shares is Fifty Thousand Dollars, (\$50,000.00). Each share of stock shall be in all respects equal to every other share.


