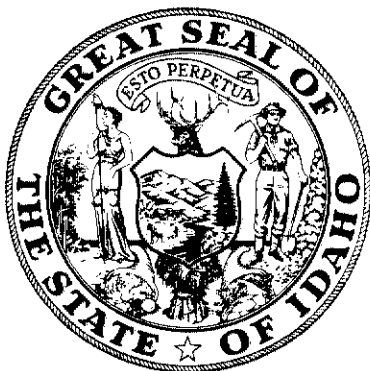

ARTICLES OF AMENDMENT
to the
ARTICLES OF INCORPORATION
of
ORCHARDS SPORTS, INC.

Pursuant to the provisions of Section 30-327 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is ORCHARDS SPORTS, INC.

SECOND: The following amendment of the Articles of Incorporation were adopted by a meeting of the members of the corporation on November 23, 1987 in the manner prescribed by the Idaho Nonprofit Corporation Act:

That Section 1 of the Articles of Incorporation be amended to change the name of the corporation from ORCHARDS SPORTS, INC. to LEWISTON SPORTS, INC.

THIRD: That the meeting of the members was held on November 23, 1987, with six of the nine members present, which was in excess of a quorum and the vote taken by the six members present was unanimous to amend the Articles of Incorporation to reflect the new name of LEWISTON SPORTS, INC.
