Articles of Incorporation of the undersigned, who is a citizen of the United States, desiring to form a non-profit Corporation under Title 30, Chapter 3, Idaho Code (Idaho Nonprofit Corporation Act) of the State of Idaho, do hereby certify:

**ARTICLE 1  
NAME OF CORPORATION**

The name of the Corporation, hereinafter referred to as the "Corporation" is Spay Neuter Idaho Pets, Inc. (SNIP, Inc.). The period of duration of the Corporation is perpetual.

**ARTICLE 2  
PURPOSE OF CORPORATION**

The Corporation is organized exclusively for charitable and educational purposes, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or the corresponding section of any future federal tax code and to that end, the Corporation is empowered to eliminate pet overpopulation by providing low-cost spay-neuter services in Idaho via stand-alone programs and collaboration with local animal welfare groups and veterinarians; to establish and maintain feral cat trap-neuter-release programs; to develop a mobile spay-neuter program for under-served areas; and to promote the benefits of spay-neuter and the humane treatment of animals through educational programs. Notwithstanding any other provision of these Articles, this Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation.

**ARTICLE 3

**ARTICLE 7  
VOTING MEMBERS**

The Corporation shall have no voting members. The management and affairs of the Corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the Corporation shall be defined by Title 30, Chapter 3, Idaho Code, and by the Corporation's By-Laws. No Director shall have any right, title, or interest in or to any property of the Corporation.

**ARTICLE 8  
DISSOLUTION**

Upon the dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding sections of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

**ARTICLE 9  
DEBT OBLIGATIONS AND PERSONAL LIABILITY**

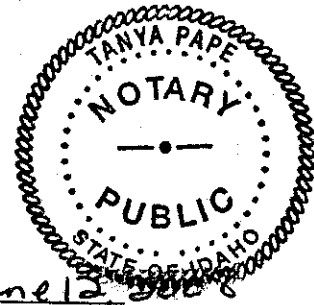
